

HOUSE RULES

RENTAL ITEMS

Rentals may be delivered from 8:00 AM on the day of your reservation. Deliveries outside of these hours may not be accommodated (with exceptions), and The Estate will not be responsible for such items. The Estate is not responsible for lost, stolen, or damaged rental items. Should the event space incur damage by a rental company, the CLIENT will be held accountable for any necessary repair costs.

<u>GENERAL</u>

The CLIENT acknowledges that The Estate may take photos of the event setup for promotional and portfolio purposes. Photos containing recognizable individuals will be taken with care to ensure privacy.

<u>CATERING</u>

Caterers must ensure the kitchen's cleanliness post-use. The CLIENT will be held responsible for any damages or unattended garbage left behind by the caterer.

HOUSE RULES

BEVERAGES

No outside beverages are permitted unless preapproved by The Estate. Violation of this provision may lead to the immediate termination of the event. No alcoholic beverages may be served to minors or visibly intoxicated individuals. Alcohol service is restricted to a maximum of five hours and must cease one hour before the event's scheduled conclusion.

If unauthorized alcoholic beverages are being consumed or possessed on the property, The Estate reserves the right to close the bar and/or terminate the event.

BOOKING & DEPOSITS

INITIAL DEPOSIT

A non-refundable deposit of \$500 is required to secure a booking with The Estate. This deposit is payable via e-Transfer to info@mallityestate.com

FINAL PAYMENT

Any remaining fees are due 7 days before the event date via credit card or e-Transfer to info@mallityestate.com

CANCELLATION & RESCHEDULING

Should the CLIENT cancel the event, the initial deposit of \$500 will be retained by The Estate as a cancellation fee. Rescheduling less than 60 days before the event date will result in the forfeiture of the initial deposit.

INDEMNIFICATION

Both parties agree to indemnify and hold harmless the other party from any third-party claims resulting from this agreement's execution.

FORCE MAJEURE

Neither party will be held liable for failure to perform its obligations if such failure is due to unforeseeable circumstances beyond its control.

GOVERNING LAW

This agreement shall be governed by and construed under the law of the province of Ontario.
